# STEEL SIDING

*Limited Lifetime Warranty*



## Film Integrity:

Premium Pro-Lap Panels have a Limited Lifetime Warranty for paint film integrity. It will not peel, flake or otherwise lose adhesion to an extent that is apparent on ordinary outdoor visual observation. Note: Slight crazing or cracking may occur on roll-formed edges or break bends at the time of forming, and is considered as standard. Such crazing or cracking shall not constitute a basis for complaint under this limited warranty.

## Fade Rating:

For a period of 35 years, Premium Pro-Lap panels will not fade more than 5 Hunter Units on vertical installations when measured per ASTM D-2244 on clean surfaces after removing dirt, other surface deposits and chalk per ASTM D-3964.

## Chalk Rating:

For a period of 35 years, Premium Pro-Lap panels will not chalk more than 8 Hunter units on vertical installations as determined by the procedure outlined in ASTM-D4214, Method A.

Specific guidelines for the steel panel paint warranty are available upon request.

MIDWEST MANUFACTURING® warrants to the original purchaser of any coated (galvanized excluded) Premium PRO-LAP® (“the product”), who purchased and installed the product, that, during the lifetime of the original purchaser (e.g. natural person), the product’s paint film will not peel, flake or otherwise lose adhesion to an extent that is apparent on ordinary outdoor visual observation. (NOTE: Slight crazing or cracking may occur on roll-formed edges or break bends at the time of forming, and is considered as standard. Any such crazing or cracking does not constitute a product defect.) For the first thirty (30) years, sidewall panels will not change color more than five (5) ΔE (delta E) Hunter units when measured per ASTM D 2244 on clean surfaces after removing dirt, other surface deposits and chalk per ASTM D 3964; For an additional final five (5) years, immediately following the first thirty (30) years, thirty-five (35) years in total, sidewall panels of Premium Pro-Lap will not change color more than five (5) ΔE (delta E) Hunter units when measured per ASTM D 2244 on clean surfaces after removing dirt, other surface deposits and chalk per ASTM D 3964; For thirty-five (35) years, sidewall panels of Premium Pro-Lap will not chalk more than a number eight (8) rating when measured per ASTM D 4214, Method A.

(NOTE: Most steel products will fade and change appearance to some degree over a period of time in outdoor installations, and such changes may not be uniform between surfaces not equally exposed. Any such changes do not constitute a product defect.) EXCLUSIVE REMEDY. MIDWEST MANUFACTURING® will replace, at its option, any Premium PRO-LAP® product that is deemed defective within the period for which this warranty applies. The original purchaser must supply MIDWEST MANUFACTURING® with the original purchase invoice indicating the date of purchase and showing sufficient Premium PRO-LAP® product was purchased to cover the amount claimed to be defective. If the product must be replaced due to peeling, flaking, loss of adhesion, color change, or chalk beyond the limits set forth above, according to the sole discretion and judgment of MIDWEST MANUFACTURING®, MIDWEST MANUFACTURING® will send the replacement product to the store where the product was originally purchased. The original retail purchaser to whom this warranty applies must then, at their own expense, pick up the replacement product. The original purchaser must pay all costs of the removal of defective product and the installation of the replacement product, including labor. No monetary compensation will be paid by MIDWEST MANUFACTURING®. MIDWEST MANUFACTURING’s® total liability is expressly limited to replacement product for any product deemed defective. This remedy shall constitute fulfillment of all liabilities of MIDWEST MANUFACTURING® to the purchaser with respect to or arising out of the product whether based on contract, negligence, strict liability in tort, or otherwise.

EXCLUSION OF OTHER WARRANTIES. THIS EXPRESS LIMITED LIFETIME WARRANTY IS THE EXCLUSIVE WARRANTY FOR THE PRODUCT. ALL IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE EXPRESSLY EXCLUDED. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF.

LIMITATION OF LIABILITY. MIDWEST MANUFACTURING® SHALL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, ANY LABOR OR OTHER INSTALLATION OR PRODUCT REPLACEMENT COSTS, LOSS OR DAMAGE TO PERSONAL OR REAL PROPERTY, INCONVENIENCE, OR LOSS OF INCOME.

This warranty only applies to the original purchaser, who must present an original purchase invoice or receipt, and is not transferable or assignable.

This warranty begins on the date that the product was purchased and continues until the warranty period elapses, OR until the property on which the product was originally installed has transferred ownership. This warranty does not cover damage that occurs through normal wear and tear and weathering of the product, misuse of the product or negligence in the use of the product, improper storage and handling of the product prior to installation, improper cleaning of the product, or lack of maintenance of the product in a manner inconsistent with or contrary to the point of sale material provided. This warranty provides you with specific legal rights, and you may have other rights under state law. Some states do not allow for the limitation or exclusion of incidental or consequential damages or limits on the length of an implied warranty, so some of the above limitations or exclusions may not apply to you.
